****Golf Cart Liability Waiver**

I, the undersigned, understand and agree to the following terms regarding the use of a golf cart at LCC:

Assumption of Risk: I acknowledge that operating or riding in a golf cart involves certain inherent risks, including, but not limited to, terrain variations, weather conditions, and the actions of other drivers. I voluntarily assume all risks associated with the use of a golf cart, including the risk of personal injury, property damage, or other loss.

Responsibility for Damage: I agree to operate the golf cart safely and in accordance with all posted guidelines and instructions provided by Loyalist Country Club. I accept full responsibility for any damage to the golf cart, the golf course property, or injury to myself or others caused by my actions or negligence while operating or riding in the cart.

Liability Release: I hereby release, waive, discharge, and covenant not to sue Loyalist Country Club, its owners, employees, or affiliates from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury that may be sustained by me or my property while using a golf cart, whether caused by negligence or otherwise.

Compliance: I agree to comply with all rules, regulations, and policies set forth by LCC regarding the use of golf carts. I understand that failure to comply may result in the loss of cart privileges without a refund.
